Position Title: Food Distribution Worker – Temporary (15 hours per week)

Position Summary:

Assemble grocery bags and perform other duties to support the food distribution process and warehouse operations. The position is in a fast-paced warehouse environment.

Essential Duties and Responsibilities:

Prepares items for food distribution. Cleans and maintains storage area and keeps it stocked at all times. Maintains effective relationships with co-workers, food suppliers, agencies and donors. Interprets for clients as needed. Assist with traffic control as needed. Performs other related duties as assigned.

<u>Qualifications</u>: To perform this job successfully, an individual must be able to perform each essential duty satisfactorily. The requirements listed below are representative of the knowledge, skill, and/or ability required.

Age: Must be at least 18 years of age.

Education and/or Experience: High School Diploma or equivalent GED

Language Skills: Ability to effectively present information and respond to questions from managers, clients, customers, and the general public. Bilingual English/Spanish or bilingual English/Vietnamese preferred.

Reasoning Ability: Ability to apply common sense understanding to carry out instructions furnished in written, oral, or diagram form. Ability to deal with problems involving several concrete variables in standardized situations.

Other Skills and Abilities: In order to achieve our mission, those that work for our organization must have the willingness to learn and understand the teaching of the Roman Catholic Church so that the delivery of our services is consistent with those teachings.
